#### 2023/24.57 Apologies for Absence

Apologies received from Cllr Gallichio and District Councillor Ray Balcombe, who had provided a written report.

#### 2023/24.60 Minutes of the Previous Meeting

It was unanimously resolved that the minutes of the Parish Council meeting held on 14th February were a true record and were signed accordingly.

### 2023/24.61 Public Participation Session

A member of the public advised she was attending to discuss agenda item 2023/24.66. She has requested the use of Paslow Common for her wedding day on 8<sup>th</sup> June. She advised she was hoping to use Paslow Common for her guests to park, due to a lack of parking at the property. Councillors agreed that it would be dangerous for cars to be parking on the road, and using Paslow Common would be the safest option. The Clerk confirmed she would be in contact to arrange to drop off and collection of the key to the Palsow Common gate. Three members of the public were in attendance to discuss agenda item 2023/24.69, and the Chairman advised he would allow them to raise their points under this specific agenda item. Local PCSO Warren Shepherd advised that the local problem resident who was bought to the Councils attention around one year ago had now been evicted. He also provided crime statistics for the area.

c) District & County Councillors Reports – District Councillor Ray Balcombe was not in attendance, however provided a written report which included the following matters:

- Cllr Balcombe is currently looking into implementing gateway signs in High Ongar to help reduce speeeding through the village.
- The Garages along The Street are currently being investigated due to reports that they are being used for storage.
- It was reported at last night's Council meeting that High Ongar had been granted the majority of the moneys for the installation of a new play area. Cllr Balcombe confirmed he would support this proposal.
- Cllr Balcombe was becoming increasingly concerned over the large number of Councillor vacancies throughout Essex.

County Councillor Jamey McIvor gave a verbal report which included the following matters:

- He advised that villages have great local people and businesses that are willing to help. If the Council have projects or matters they feel could be tackled without the help of Essex County Council, they should do so.
- Cllr McIvor has submitted an LHP Application to increase fencing by the school.
- He briefly discussed Ride London, and advised if anyone had any issues or questions to please contact him.
- Various Highways matters.

### d) Parish Councillors

- Ward Councillor Report Paslow Common Cllr Smith advised that there was good communication surrounding the issue of the rubbish burning at Woolmongers lane on the WhatsApp group.
- Ward Councillor Report High Ongar None
- Ward Councillor Report- Norton Mandeville Cllr Bosworth advised that Norton Lane was still in a terrible state due to unfilled potholes. The Clerk confirmed she would make contact with Cllr Jaymey McIvor.

f) High Ongar Village Hall – Cllr Funnell advised that the Village Hall has had to dispose of a number of outside tables and chairs due to health & safety concerns. The previous Locum Clerk advised that High Ongar Village Hall was being looked at in the next round of funding for a possible grant. The Clerk confirmed that this would be on the next agenda to discuss the possibility of the Parish Council providing the funds by way of a grant.

# 2023/24.63 Clerk's Report

The Clerk gave a verbal report which included the following matters:

- Confirmation of an uncontested election with 7 Councillors standing for election. All Councillors who stood have been re-elected unopposed.
- The Clerk has been contacted by Chanel 4 seeking information surrounding a field behind a home along Mill Lane.
- The Clerk has ordered a free portrait of the King, which was being offered to all Village Halls. Cllr Funnell advised that the portrait was not needed.

# 2023/24.64 Millfield Play Area

The feedback received from the Millfield Play area consultation was tabled at the meeting. A detailed discussion occurred where Councillors raised various concerns if a play area was

installed, as well as discussing what a great benefit this would be the for Children in the area. A detailed discussion took place as to the benefit to the area as well as what complexities may occur if a play area was installed. After further discussion, and on the basis of sending out the consultation documents specifically naming Millfield, it was proposed by Cllr Tory to use Millfield Green as the location for the proposed play area. This proposal was seconded by Cllr Bosworth. A vote took place, the outcome of which was a majority decision. 5 for, 1 against and 1 abstention. A second proposal was made by Cllr Tory to accept the grant funding, and this proposal was seconded by Cllr Catilin. A vote took place, the outcome of which was a majority decision. 5 for, 1 against, 1 abstention.

It was agreed that a statement would be drafted and released, confirming the outcome of the meeting.

#### 2023/24.65 Local Highways Pannel – Speed calming measures

Cllr Acton felt that High Ongar was a great candidate for the 20 is plenty campaign. Cllr Jaymey McIvor agreed to support the application and suggested providing evidence as to the speeding issue such as statements from local residents.

#### 2023/24.66 Resident request for use of Paslow Common

This item was discussed in agenda item 2023/24.61.

#### 2023/24.67 Community Speed Watch Group

A detailed discussion occurred surrounding this matter. Cllr Catlin was happy to look into the possibility of reinvigorating the community speed watch.

#### 2023/24.68 LHP Application – Safety measures surrounding High Ongar Primary School

Cllr McIvor advised in his report that he had submitted an LHP Application for increasing fencing at the school. He detailed within his application that if fencing was not possible then another option be provided.

#### 2023/24.69 Woolmongers Lane, Paslow Common ward - Continuous ongoing issue of rubbish burning

A number or residents in attendance detailed the increased problems they are facing due to the continuous rubbish burning at various scrap yards at Woolmongers Lane. The previous Locum Clerk confirmed that District Councillor Ray Balcombe was the Contracts, Service Delivery and Improvement portfolio holder, and that she would contact him to ask how to move forward with this matter. Residents in attendance provided the Clerk with their email addresses so she could keep them informed of future correspondence.
