2024/25.13 Internal Audit

Councillors are asked to consider approaching Val Evans to be this Councils Auditor for 2024/2025. This would come at a cost of between £150-£200. To note the internal Audit of 2023/2024 has been conducted by A. Jones for no cost, however going forward this will not take place.

2024/25.14 Review of effectiveness of Internal Control

Each year the parish Council is required to review the effectiveness of its internal Controls. Councillors are asked to consider this matter. The Clerk will provide an update.

2024/25.15 External Audit

Each year the Parish Council is required to submit to an External Audit by an externally appointed Auditor. For 2023/2024, and for the next 5 years, this will be PKFLittlejohn, and the Audit is known as the Limited Assurance Review. An Annual Governance and Accountability Return (AGAR) needs to be completed and approved by Council. The limited assurance review was created to provide reassurance and transparency to local residents. For the 2023/2024 financial year, this Council is eligible to classify itself as Exempt from the review as it meets the following criteria set out in section 9 of the Local Audit (Smaller Authorities) Regulations 2015:

- total gross income and total gross expenditure below £25k; and
- no public interest report/statutory recommendation/advisory notice/judicial review/application to court re unlawful item of account issued by its external auditor for the 2022/23 year; and
- the relevant financial year is not one of the first three years of the authority's existence.
