# 2024/25.192 VE Day commemorative event

At the previous meeting a small working group was formed to liaise regarding the organisation of a VE day event in High Ongar. An update regarding the progress of this will be provided at the meeting.

### 2024/25.193 High Ongar Grass Cutting

At the previous meeting Councillors felt that fortnightly cuts of various open spaces in High Ongar may not be necessary. It was requested that the Clerk advise Thornwood Ground maintenance (TGM) of the Council's budget and ask they are able to provide cuts around this. The Clerk has been in contact with TGM and the below grass cutting schedule had been informally agreed by Council:

**Grass cutting locations**: Paslow Common and strim around bollards, The Allotments, Triangle Rookery Road.

**Schedule:** 1 cut in March. 2 cuts a month in April, May, June. July and August – cut as needed due to hot and dry conditions 2 cuts in September (if needed) 1 cut in October

TGM have confirmed that they will stick to the agreed budget of £1,800 per year for grass cutting, which was previously agreed by this Council.

Council is asked to formally agree the above grass cutting schedule for 2025.

### 2024/25.194 Street Light – electrical testing

At the previous meeting Councillors were provided with an electrical testing report which was completed on all streetlights owned by the Parish Council in High Ongar. One unit was identified as having several very significant structural defects that affect the units continuing performance, and it was recommended that the unit was replaced as soon as is reasonably practicable. A quote for the repairs had been provided, and Councillors felt that they would like to inspect the streetlight themselves before anything is agreed. Councillors are asked to agree how they wish to proceed with this matter.

### 2024/25.195 Rural England prosperity fund 2025/2026

The Rural England prosperity fund for 2025/2026 is open for applications. This grant is for capital expenditure only and awards are anticipated to be from £10,000 to £50,000 with a minimum of 20% match funding or external funding added to the amount you bid for. Delivery of all projects must start immediately after the funding is received and be completed and delivering the projected benefits within a year. One of the aims of the fund is to support new and improved community infrastructure, providing essential community services and

assets for local people and businesses to benefit the local economy. Councillors are asked to consider if they have any projects that they would like to apply for funding via the Rural England Prosperity fund.
