<u>f) High Ongar Village Hall</u> – Cllr Acton advised that various works have been happening in the Village Hall. He also confirmed that PAT testing and a Health & Safety and fire assessment has been scheduled.

<u>g) Police Reports</u> – PC Warren Shepherd provided a written report which was read by the Clerk, the report included the below statistics within the area for the last three months:

29 calls to police, of these calls 10 crimes were recorded. Of those 10 crimes the following are crimes considered to have an impact on community:

- 2 Residential Burglary Non-Dwelling
- 1 Theft from Motor Vehicle
- 1 Vehicle Interference
- 2 Theft of Motor Vehicle

Stats for period 01/04/23 to 01/07/23 28 calls to police, of these calls 20 crimes were recorded 1 Residential Burglary Non-Dwelling 1 Theft of Motor Vehicle

Stats show a 3.5% increase in calls to police but despite this increase, crime is down 50%.

#### 2024/25.92 Clerk's Report

The Clerk provided a verbal report which included the following matters: The damaged sign that was raised by Cllr Funnell last meeting had already been reported to Highways. This however was reported again by the Clerk.

- The Caterers for the Christmas Lunch were unfortunately not available for the dates required. Cllr Catlin is currently in the process of trying to organise another caterer.
- Cllr Jaymey McIvor has confirmed he will support High Ongar in the 20 is plenty campaign that this Parish Council is hoping to implement. The Clerk is currently in the process of completing an LHP Application.

#### 2024/25.93 Play Area Funding

The possibility of a future play area has been discussed by this Council for some time. Before any grant funding is sourced the Clerk has asked that a location be agreed.

Councillors discussed the above matter in great detail. Although a possible plot within Mulberry House had previously been discussed, Councillors felt the Village Green which is located within the grounds of the Village Hall is the most appropriate location. Although the finer details surrounding this location are still to be determined, it was agreed by Councillors to pursue this location. The Clerk noted that funding form different grant opportunities would need to be sourced in order to have the funds to install a play area.

#### 2024/25.94 Unity Bank Savings Account

Councillors agreed to open a Saving Account with Unity Trust Bank, and to begin with all Earmarked funds transferred into this account.

#### 2024/25.95 Remembrance Day

The Chairman confirmed that a wreath is laid on the memorial on the Saturday and again at the Church service on the Sunday. The Clerk confirmed she will order a wreath for the event.
